In respect of all issues relating to data processing carried out by CIB Bank as a financial institution that were not addressed in this policy – in particular rights of data subjects and their enforcement – rules established by the general [Data protection and data security policy](#) adopted by CIB Bank shall apply.

According to Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation)

(i) you may have access to your personal data, and ask for information about your personal data processed by CIB Bank Zrt.. CIB Bank Zrt. provides a copy of the personal data undergoing processing for free. For any further copies requested by the data subject, the controller may charge a reasonable fee based on administrative costs.,

(ii) you have the right to request from the controller rectification or erasure of personal data or restriction of processing of personal data,

(iii) you may ask for information on which recipients have been informed about the erasure, the rectification or restriction of data processing,

(iv) if the data processing is based on your consent, you have the right to withdraw your consent at any time. The withdrawal of consent shall not affect the lawfulness of processing based on consent before its withdrawal. CIB Bank Zrt. may process your personal data after the withdrawal of your consent in case the processing is necessary for compliance with a

legal obligation or is necessary for the purposes of the legitimate interests pursued by the controller, in case the enforcement of this interest is proportional to the restriction of the right to personal data protection,

(v) in case the processing of personal data is based on your consent or on the performance of a contract, you may have the right to receive the personal data, provided by you to a controller, in a structured, commonly used and machine-readable format and have the right to transmit those data to another controller. You may also ask CIB Bank Zrt. to transmit your personal data directly to another controller.

You may request the investigation of the Hungarian National Authority for Data Protection and Freedom of Information (1125 Budapest, Szilágyi Erzsébet fasor 22/c., postacím: 1534 Budapest, Pf.: 843, website: www.naih.hu, telephone: +36 (1) 391-1400, fax: +36 (1) 391-1410, e-mail: ugyfelszolgalat@naih.hu) regarding the lawfulness of the data processing. We suggest that you connect our data protection officer before you turn to the Court or the Authority.
